Engineer Hunter Baumgardner opened and read the bids as follows:

- **Mainline Construction** – Bidder provided an electronic copy, an original paper bid, and 7 paper copies as required, Total Bid Price - **\$4,465,529.94 – 3rd**
- **Royal American** – Bidder provided an electronic copy, an original paper bid, and 7 paper copies as required, Total Bid Price - **\$4,688,944.72 – 4th**
- **L & K Contracting** – Bidder provided an electronic copy, an original paper bid, and 7 paper copies as required, Total Bid Price - **\$5,536,717.80 – 7th**
- **C W Roberts** - Bidder provided an electronic copy, an original paper bid, and 7 paper copies as required, Total Bid Price - **\$7,274,552.02 – 8th**
