

EMERGENCY ORDINANCE #2005-1017L

AN ORDINANCE FOR THE CITY OF WEWAHITCHKA, GULF COUNTY, FLORIDA, AMENDING DEPOSITS FOR WATER, SEWER, AND GARBAGE SERVICES FOR RESIDENTIAL AND COMMERCIAL CUSTOMERS AND PROVIDING FOR AN EFFECTIVE DATE

BE IT ORDAINED BY THE PEOPLE OF WEWAHITCHKA, GULF COUNTY, FLORIDA:

WHEREAS, the people of Wewahitchka, Florida, established the deposits required for water and sewer services through Ordinance #11-14-89-1 amended by Ordinance #6-10-91-2 and deposits required for garbage pick-up only through Ordinance #3-11-2002; and

WHEREAS the City Commission has determined a need for an increase in the deposits for these services;

NOW THEREFORE, the following deposits shall be established and shall be effective as of **September 26, 2005**, and this Ordinance shall be in addition to and amending all previous Ordinances covering the deposits, connection fees, reconnection fees, for services:

Those customers having a current deposit and excellent payment record with the City shall be allowed to transfer the existing deposit to a new service address with no increase in deposit provided all previous accounts at all previous service addresses are paid in full at the time of transfer of deposit.

All other provisions of previous Ordinances and Amendments to previous Ordinances not in conflict herewith, shall remain in full force and effect. Ordinances affected include but may not be limited to Ordinance #11-15-93; Ordinance #11-21-94; Ordinance #5-24-99; Ordinance #6-10-91-2; Ordinance #11-14-89-1; Ordinance #12-3-91; Ordinance #2003-08-11; Ordinance #2003-1001L.
